In the light of Egypt's severe economic crisis, Egyptian President Abdel Fattah El-Sisi, who was the main guest at the Republic Day parade on Thursday, has approached India for investments and participation in massive infrastructure projects in his country.

According to sources, this was one of the recurring topics of conversation between the Egyptian side and Indian leadership over the past two days, including Prime Minister Narendra Modi. At a time when China's economic ties to Egypt have grown over time, these discussions took place.

This push was also reflected in the joint statement that was issued by both sides. In it, both leaders said that they were pleased with the expansion of Indian investments in Egypt, which currently amount to more than \$3.15 billion. It stated that they had agreed to encourage businesses from each country to investigate emerging economic and investment opportunities in the other.

"Egypt pledges to offer incentives and facilities in accordance with relevant frameworks and rules, and welcomes the influx of additional Indian investments. India, on the other hand, emphasizes its support for this strategy by encouraging its companies with the potential to invest abroad to take advantage of Egypt's investment opportunities, it stated.

According to sources, Sisi emphasized Egypt's eagerness to develop economic and trade cooperation with Indian companies as well as joint investments

during meetings in Delhi with Indian leaders like President Droupadi Murmu and External Affairs Minister S Jaishankar.

Sources say that the Egyptian president said that mega projects in Egypt offer a variety of investment opportunities.

The Suez Canal economic zone, the second channel of the Suez Canal, and a new administrative capital in the suburbs of Cairo are among the major projects that were highlighted, even though Egypt has not requested budgetary support.

They stated that one of the most important aspects that was emphasized was the development of the Suez Canal region, which includes a number of significant industrial and logistics zones. According to the joint statement, The Indian side is able to arrange for the master plan, and the Egyptian side is considering the possibility of allocating a special area of land for Indian industries in the Suez Canal Economic Zone (SCEZ).

Sources say that Sisi told businesspeople in Delhi at a meeting that Indian companies can benefit from Egypt's strategic location as a center for production and re-export to many countries linked by free trade agreements, especially in the Arab world and Africa. Senior representatives from the ministries of Commerce, Finance, and External Affairs also attended this meeting. More than fifty Indian companies currently have investments in Egypt worth more than \$3.15 billion. Egypt, on the other hand, has only about

\$37 million invested in India. India's trade with Egypt has increased to \$7.26 billion in 2021 and 2022, up from \$4.5 billion in 2018-19.

In spite of the difficulties posed by the pandemic, the two leaders were content with the level of bilateral trade, according to the joint statement. According to the report, "they expressed confidence that by diversifying the trade basket and focusing on value addition, both countries could achieve a bilateral trade target of US\$ 12 billion within the next five years."

Additionally, Sisi has visited China seven times in the past eight years, including for the 2022 Winter Olympics in Beijing. At the moment, the value of bilateral trade between China and Egypt is \$15 billion.

However, Egypt is experiencing a spike in inflation that has reached a five-year high of 21%, resulting in high prices for necessities like eggs, milk, and basic food.

In addition, the value of the national currency has decreased by nearly half in less than a year, reaching a record low near the 30 Egyptian pound-to-dollar mark. Additionally, the nation has requested a bailout from the IMF for the fourth time in six years, receiving \$3 billion over four years.

In addition, their tourism-dependent economy was impacted by the pandemic and the Russia-Ukraine war, which had an effect on Egypt's forex reserves and food grain supply—almost 80% of Egypt's food grains came from Russia and Ukraine.

Egypt's forex reserves once stood at \$20 billion, but they are now \$34 billion. They have sought financial assistance from Saudi Arabia and the United Arab Emirates, receiving approximately \$8 billion thus far. In May of last year, 61,500 metric tons of wheat were allowed to reach Egypt from India, which had banned the export of wheat.

According to sources, Sisi informed his interlocutors in Delhi that Egypt is prepared to achieve "industrial integration with Indian companies" and encourage the growth of Indian businesses through partnerships.

According to sources, businesses in India and Egypt will investigate ways to maximize cooperation in the pharmaceutical, communications, information technology, and defense sectors. Infrastructure, petroleum and natural gas, new and renewable electricity, energy, and agricultural products are also on the radar.

Strong ties with Egypt, which occupies a significant geostrategic location, are essential for India. Egypt is a significant political player in both west Asia and north Africa, and the Suez Canal accounts for 12% of all global trade. Additionally,



it is the most populous nation in west Asia, making it a significant market and entry point to Europe and Africa. Egypt also has bilateral trade agreements with prominent African and Arab nations.



"With China nearby," the sources say, "there are strong geoeconomic and geostrategic reasons for India to have a significant foothold in Egypt."

The nearest airport is Nagpur. We left from Mumbai by the Nagpur Duronto Express, which left Mumbai around 8.20 p.m. and reached Nagpur around 7.30 a.m. the next morning.

By the time the train reached Nagpur, we were all ready and excited to reach our destination. Our drivers were experienced and knew the way inside and out. We had a quick stop for breakfast at Nagpur and then set off for a journey of around 3–4 hours to Tadoba.

The resort where we stayed was located in the buffer zone of the jungle. We were informed that at night we would be able to hear the noises of the jungle and the calls of deer as the tigers set out to hunt. We were eager to hear those, but first, it was time for our first-ever safari. We were all very excited and wanted to see a tiger real soon. However, I had already been taught that the jungle is the tiger's natural habitat. So, we might or might not get lucky enough to see one. The key is to enjoy the jungle, remain quiet, and listen to the voice of nature. I did just that.

We were instructed to turn off the alarms before entering the forest, then switch off the mobile phones and hand them over to the guide. Due to various reasons, mobile phones are not allowed inside the Tadoba Andhari Tiger Reserve. The guides in Tadoba are highly conversant with the history and geography of the reserve and brief the tourists about the jungle in the first few minutes of the safari.

India has more than 52 tiger reserves, of which Tadoba Andhari Tiger Reserve is Maharashtra's biggest tiger reserve. It covers six districts in Maharashtra and covers an area of more than 1700 square kilometers. There are more than a hundred tigers, of which only about 18–20 are available for tourists to see, as the tourist gypsies cover only about 20% of the forest. The rest is accessible only by the forest department.

Besides tigers, many other wild animals also live in the jungle, among which there are leopards (more than 40), sloth bears (more than 100), and wild dogs (more than 400). All these are referred to by the guides as "VIP animals." However, the probability of sighting them is very low. Apart from them, we can spot various deer, Indian gharials, wild boars, and many species of birds.

The information was interesting. He also knew about the history of the jungle, the significance of the pillars that we saw every 100 metres or so, and various flora in the jungle

(one of which was scary—he said it changes colour in every season and is called "Devil tree"). However, a lot of land is covered by bamboo trees, which bloom only once in their lives. Bamboo trees die once they flower. This was a new fact that I learned.

As we went inside the forest, we spotted many animals. Sambar, wild boar, spotted deer, langur, even an owl—we were eager and desperate to spot a tiger. The driver and the guide were experienced and knew where the probability of finding a tiger would be highest. But even after roaming around for more than 2 hours, we were yet to spot even the whiff of a tiger. And then suddenly, our gypsy stopped. Our guide pointed towards a distant spot and said that he could spot Maya, the tigress. Every one of us got excited and tried to spot her, but we were unable to. That was until I used the binoculars to find her. The tigress was sleeping after perhaps a hearty meal. We waited for quite some time but were unable to see her in action.

For the next safari, we were in search of the tiger again, but all we could see were lots of deer, sambar, and wild pheasants. The main attraction was still missing. Disappointment set in, but we were kept engaged by the quide's interpretation of various sounds and sights of the jungle. And then suddenly our guide told us to hold tight, and the driver rode through the jungle like a madman. The adventure was more terrifying than seeing a tiger up close. We were avoiding the branches and braving the jungle paths and bumps along the way. Only when he arrived at the location did he inform us that a tigress and her cubs had been spotted, one of which had gone missing and she was looking for it. We eagerly waited, jumping at every sound and looking here and there aimlessly for a glimpse of the tigress, but even after waiting for an hour or so, she didn't appear. Our quide said she must have crossed over to the other part of the jungle. All the waiting vehicles left the forest area dejected that day.

We were told that we can learn three things from the forest: patience, perseverance, and discipline (PPD). So we must now be patient and believe that we will see a tiger on one of the two remaining safaris. We regained our energy after lunch and enjoyed ourselves until the evening, when we were to proceed for the penultimate trip through the jungle. PPD was reverberating through our minds. We were determined to search for a tiger this time. As time passed by and we saw only other birds and mammals, we started getting disappointed again when suddenly our guide told us to pay attention to the surroundings. There were numerous deer and monkey calls going on. Our hearts started pounding in anticipation of the sighting. And our driver drove through the forest

until we arrived at a swamp where we had the best chance of seeing the tiger.

He parked the vehicle, and we thought we would again have to wait. But he excitedly pointed in one direction and whispered, "Look that side." "Taru is sleeping." Hearing the word "sleeping" reminded us of Maya, who had kept sleeping throughout, and frustration started creeping in. But then we saw him. The beautiful tiger was sleeping barely 20 metres from where we were parked. Whoa! was all we could think since none of us wanted to disturb his peace by saying anything. He was rolling around from time to time, and when crows or flies disturbed him, he would just give a small growl and move his tail. He must be taller than a 6-foot-tall man if he stood on his hind legs. Just as we thought he was also going to keep sleeping like Maya, the majestic being shook his body and leisurely sat down. Looking at us with a deep, piercing gaze, unbothered by the chatter of people around him, he stood up slowly, as if in slow motion. The photographers had a field day merrily clicking away, the deafening shutter sounds all around us as he stood up and started walking in a catwalk, fit for the glorious animal that he is. Although we were scared in our hearts, we were awed by the royal sight we beheld before us. He was the least bothered by all the attention he was getting. He stood up and looked around at all the vehicles parked there, as if sizing them up as a king would size up his subjects.

And then, to the dismay of the photographers, he sauntered away from us towards the inviting woods and sunshine, which, we later realized, had receded from where he was sleeping. We were mesmerised and didn't think of talking even after he had gone far from sight. Such was the grandeur, the hypnotic scenery, and the awe-inspiring experience that we just stood there enjoying our first-ever sight of the tiger in its natural habitat

People have had experiences with tigers hunting, mating, or fighting, but our first experience was this. And boy, am I hooked on to this! I'm planning another tour in May 2023, this time to another tiger reserve called Pench (Madhya Pradesh). I hope to be able to get more sightings during that trip. I will get back with a recall once I have finished with it.

#### Rava Kesari or Shira

Shira or Rava Kesari is a popular sweet dish in India, it is a traditional sweet that is made in many Indian homes during festivals and special occasions. It is a delicious and easy-to-make sweet dish that can be enjoyed by all.

#### **Ingredients:**

- 1 cup fine semolina (rava or sooji)
- 1 cup sugar
- 1 cup water
- 1/4 cup ghee (clarified butter)
- A pinch of saffron strands
- A few drops of yellow food colour (optional)
- 2 tablespoons chopped cashews and raisins (optional)

#### Instructions:

- In a pan, dry roast the semolina on medium heat until it turns slightly golden brown and releases a nutty aroma. Keep stirring continuously to prevent burning.
- In another pan, bring water and sugar to a boil. Add saffron strands and food colour, if using. Stir to combine.
- Once the semolina is roasted, add the sugar syrup to it and stir continuously.
   The mixture will start to thicken.
- Add ghee to the mixture and stir well.
- Keep stirring until the mixture becomes thick and starts to leave the sides of the pan.
- Add cashews and raisins, if using, and stir well.
- Transfer the mixture to a greased plate or container and press it down evenly.
- Let it cool for a few minutes, then cut into desired shape and serve.

**Note:** You can also add cardamom powder or rose water for flavour.




The US is a fascinating country, and living in multicultural places like New York and California has enabled me to embrace American values while staying true to my Indian heritage.

I kept thinking in my mid-20s about not being able to pursue more Carnatic music, and it so happened that, a few years after my first daughter Sanchitha was born, I was introduced to a local Carnatic teacher. This rekindled my passion for learning again, and I got into listening to music more seriously. I used to live in New York, and my teacher was in Connecticut, but I would drive an hour each way once a week (usually on a weekday after work). I enjoyed it so much that the drive did not bother me, as I always had music for company no matter how long the drives were.

In parallel, I started helping organise music events—in my local community with a few other ladies and for our local temple. This art had given me so much "listening" pleasure by that point, and I was always fascinated by the depth of ragas and scales, and where creativity could take a simple "Rasika" like me—that I felt compelled to help the art and artists, and to be involved in spreading the art wherever I could in the United States.

As a result of this, I met (and hosted) many professional Carnatic musicians and was astounded by their lives—how they constantly think about and breathe music.It drew me more and more to this art, and it made me more open to managing events as an individual. When Sanchitha was about 5, I would take her along to learn from my teacher; we would have back-to-back classes. And Saadhvi, who was about 4, joined us, so this became a fun family event and a great mom-daughter bonding opportunity, and we had so many songs that we tried singing together or exploring the details behind them.

I feel fortunate that both my daughters have continued learning Carnatic vocal for the past 15+ years, moving on to learning from a professional musician from Chennai. They have performed more than 50 full-length concerts to date, including at the prestigious Chennai music season in December. I am not sure whether they will take up music full-time, even though they certainly



have the talent and mindset for it, but even if not, I am confident music will give them peace of mind and joy in their lives, just like it has for me.

After moving from New York to California in 2014, I was excited to find an active music community. In 2019, I was elected President of the South Indian Music Academy (SIMA). #### What opinion do you have regarding Indian kids brought up in India vs. abroad?

I think there used to be a more significant difference 15-20 years ago, where Indian kids brought up in India used to primarily focus on education, while US kids were encouraged to explore different things outside of the standard engineering and medical fields.

Especially when kids are in their 20s, I feel they should do this before deciding what they are most passionate about pursuing long-term. It is unnecessary to confine them to one or two professions simply because that is what their parents and ancestors did. The world is a big playground.



Few people would have heard of Luciano Narsingh. Fewer know that the Dutch footballer of Indian origin, who represented the Netherlands in the Euro Championships and the World Cup, missed playing for India by a whisker. Narsingh's class and pedigree can be gauged from the fact that he has scored goals against world powers like England and Belgium. Unfortunately, an injury cut his career short.


The 32-year-old Naringh, who was born in Amsterdam and generally plays on the right flank but can also play on the left, joined Dutch giants PSV Eindhoven as a 12-year-old prodigy for a staggering €4 million transfer.

Narisingh's grandparents were from Andhra Pradesh and settled down in Surinam, a Dutch colony in South America. He was born in Amsterdam in 1990 and started playing football at a very young age. He has an elder brother, Furdjel Narsingh. Both siblings were quite talented, and it was only a matter of time before both were snapped up by FC Eridivise, one of the leading clubs in the Netherlands, for their junior side.

Thereafter, it was Narsingh who caught everyone's eye with his exceptional skills. As a 12-year old, he displayed enough amazing skills to be seen as something of a standout player. In fact, many of the scouters for the Dutch big clubs were hovering around him in order to access his talent and also get him drafted into their respective clubs.

Such was Narsingh's talent that the reputed Dutch coach, Ron Jans, waxed eloquently about the prodigy. Speaking on Dutch media, he said, "Narsingh is one of the quickest players ever to have played in Holland.

His speed is simply phenomenal, and his ability to spot the openings in the rival defence was incredible." Such high words of praise go to show the type of rare talent Narsingh had.



Things were looking very bright and rosy as he was touted as the next big thing in the future of Dutch football. His biggest moment at the junior level came shortly after this, when PSV Eindhoven bought him from FC Eridivise for a record 4 million Euro deal. At that time, Dick Advocaat, who coached the Dutch team twice



in the 1992 and 2002 World Cups, was a big fan of his and it seemed that Narsingh would make his debut in the national side anytime. But in 2013, misfortune stuck with Narsingh. He suffered a freak knee injury and had to sit out of action for almost a year. This proved to be a big whammy in more than one way, as not only did he lose out on precious experience, but this period also coincided with Advocaat leaving the club to be replaced by Phillip Cocu, who didn't "seem" to be impressed with Narsingh. His return to action proved to be a sedate affair, as he was kept out of PSV's important league matches.

There is an adage that form is temporary but class is permanent. Narsingh waited for his "moment," which arrived when he was selected to play against Dutch champions Ajax. Ajax were the Dutch champions for the last four years, and Narsingh showed his class when he scored a brilliant header that enabled PSV to stun Ajax. That goal was to give his career a new boost and propel him to fame, as it was the first time Ajax had been defeated in a domestic match in four years.



Narsingh's brightest moments came when he was part of the Netherlands team for the 2012 Euro Championships, and he played a very active role in ensuring that the Netherlands qualified for the 2014 World Cup in Brazil. He scored a goal against Switzerland and was involved in four more assists as the Dutch qualified for the World Cup. However, bad luck once again surfaced when he suffered a hamstring injury a month before the tournament and had to miss

a golden chance to represent the Netherlands. To this day, his inability to play in the World Cup remains his biggest disappointment.

#### Almost represented India

During the period in which Narsingh was actively involved in Dutch football, he was contacted by certain Indian football officials in 2012–2013. It is understood that Narsingh had expressed his desire to play for



India. He had Dutch citizenship and, as per FIFA rules, could play for India without renunciating his Dutch citizenship. However, the Indian government made it mandatory for any sportsperson representing the country to hold an Indian passport. Narsingh, whose career was taking off at that time, could not afford the risk of losing his Dutch passport—and that prompted him to stick on to his Dutch citizenship.


