



Rabindranath Tagore's Formative Years: A Foundation for Genius

Rabindranath Tagore's journey to becoming a global literary giant began in 19th-century Calcutta, a bustling cultural centre. Tagore was born on May 7, 1861, into the legendary Tagore family, which was known for its deep influence on Bengali culture and intellectual life. His upbringing was rich in arts, literature, and music. Tagore showed an early interest in the arts. At a young age, Tagore started composing poems, demonstrating a great aptitude that his family's support encouraged. His early paintings exhibited the depth and sensitivity that would become characteristics of his later work. However, Tagore's education extended beyond the confines



of his family estate. He travelled extensively, Tagore's humanity is perhaps the most first with his father across India and then to England. These journeys greatly enlarged his perspective, exposing him to a variety of philosophies, civilizations, and literary traditions. The synthesis of Eastern and Western philosophy became an important characteristic of his work, allowing him to use his art to establish bridges between disparate worlds.



Tagore laid the groundwork for a lifetime of artistic and intellectual discovery during these formative years. His one-of-a-kind childhood, enriched by numerous influences, turned him into a global citizen and a champion of universal human ideals. This period laid the groundwork for his tremendous contributions to writing, music, and ideas, which would leave an indelible impression on the world.

Rabindranath Tagore, often known as Rabi, was the thirteenth child. His mother died when he was a toddler, and at the age of eleven, he travelled across India with his father. Throughout his voyage, was able to read the writings of notable writers, including the classical Sanskrit poet Kalidasa. He returned home and wrote a lengthy poem in the Maithili manner.

Tagore's father sent him to Britain in 1878 at the age of seventeen to pursue formal education, hoping he would become a lawyer. He grew up in Brighton, East Sussex, before attending University College London for a short time. Tagore began studying Shakespeare's writings during this period. Although he returned to Bengal two years later without a Tagore degree, received encouragement to develop his own creative work bν combining parts of Bengali and European traditions. In 1882, he received widespread praise poem for his collection, "Nirjharer Swapnabhanga."

Rabindranath Tagore, the son οf Sarada Devi and Debendranath Tagore, prominent religious reformer, had key influence transforming Bengali literature music. Debendranath Tagore, a Brahmo Samaj leader, ensured that Rabindranath grew up in an environment where philosophical debates and cultural activities were the norm. He also brought India's rich cultural history to the Western world and was the first non-European recipient of the Nobel Prize.

The Nobel Prize was awarded to A Literary Titan, the first non-European recipient.

Tagore became the first non-European to receive the Nobel Prize in Literature in 1913. He received the award following the publication of his outstanding book of poems, Geetanjali.



According to the Nobel Committee's announcement, Tagore was honoured for his profoundly sensitive, fresh, and beautiful verse, by which, with consummate skill, he has made his poetic thought, expressed in his own English words, a part of Western literature.

Regrettably, thieves stole the prize from Visva-Bharati University's security vault in 2004. Later, the Swedish Academy gave Visva-Bharati University two replicas of the prize, one made of gold and the other of bronze.

Tagore's literary canvas was expansive, spanning a wide range of genres. "Gora," "Ghare-Baire" (The Home and the World), and "Chokher Bali" are comprehensive studies of complicated social and philosophical subjects that exhibit his tremendous humanity and understanding of human connections. His poetry, which is frequently linked with the environment, expresses profound ecological conscience and a sense of oneness with the natural world. Tagore's writing, with its lyrical beauty and philosophical depth, continues

to inspire and connect across cultures, making him not only an Indian national treasure but a global literary genius. His literary achievements are more than just a reflection of his creativity; they are a legacy that continues to enlighten and connect hearts around the world.

Tagore's Nationalism Vision: A Thought Leader Beyond His Time

Rabindranath Tagore's take on nationalism distinguished him from his contemporaries. While deeply committed to India's freedom struggle, Tagore held a understanding complex nationalism. He warned against its tendency to breed division parochialism, instead arguing for global humanism. In contrast to leaders such as Mahatma Gandhi, his scepticism of strong nationalism arose from conviction in global interconnectivity and humanity's unity. Tagore championed the society where idea of а humanity transcended political and geographic divisions in his articles, lectures, and literary works, a vision that is as pertinent today as it was in his time

Tagore was an active member of the nationalist movement and had a close relationship with Mahatma Gandhi. He was extensively involved in numerous fields οf art. literature, and music, and he even moved into painting in his sixties, exhibiting his talent as recognised contemporary artist in India.

Tagore's Among fascinating facts is the theft of his Nobel Prize 2004 and in its replacement by the Foundation. His esteem spread beyond India, with important figures such as WB Yeats and Andre Gide praising his work.

Tagore was well-known for his respect for Mahatma Gandhi, both as a political leader and as a person. Tagore was the one who coined and popularised the title 'Mahatma' for Gandhi. Despite this, they maintained opposing viewpoints on science,

nationalism, and social and economic growth.

It's worth noting the kind of interaction Tagore had with Mahatma Gandhi. Tagore liked Gandhi but disagreed with him Tagore some matters. οn admired Mahatma Gandhi immensely and expressed his admiration for his leadership time and again, but sharply differed with him when Gandhi was departing from adequate reasoning.

According to a recent post on Scroll.in, Gandhi blamed the 1934 Nepal-Bihar earthquake on the practice of untouchability among Biharis. The quake, according to Gandhi, was "a divine chastisement for the great sin we have committed against those whom we call **Harijans**."

Though Tagore was opposed to untouchability, he thought Gandhi's reasoning was unreasonable. Tagore sent a rebuttal on rationalist lines to Gandhi's journal, Harijan, with a request for its publication. The letter expressed 'painful 'this kind of surprise' at unscientific view of things'. It was simply inaccurate, Gurudeb argued, to associate ethical principles with cosmic phenomena.

Gandhi believed that man's values were somehow connected to catastrophes such as droughts, floods, and earthquakes, despite their seemingly physical origins.

Tagore's Educational Odyssey: Visva-Bharati University's Vision

Tagore interested was in societal development addition to his literary endeavours. While managing family's properties, gained a better grasp of human nature and pursued his interest in social reform. Inspired by Upanishadic ideas, he entered the field of education and established Shantiniketan, an experimental school.

The creation of Visva-Bharati University by Rabindranath Tagore was a groundbreaking breakthrough in educational reform, expressing his vision of

system an education that blended Indian and Western concepts. Tagore believed in building an environment that valued creativity free and beyond thought, going educational traditional conventions. Visva-Bharati was more than a university; it was a community where global cultures collided and learning went beyond textbooks. Tagore hoped to produce global citizens through this unusual educational experiment, a vision that continues to influence educational philosophies around the world.

Beyond the Written Word: Rabindranath Tagore's Artistic Spectrum

Rabindranath Tagore's artistic included substantial path contributions to music and addition painting in literature. Rabindra Sangeet, his musical legacy includes over 2,000 songs that merge classical Indian music with his creative genius, resonating powerfully in beyond. Bengal and These works. revered for their emotional depth and cultural diversity, remain an important element of Bengali identity. Later in life, Tagore's move into painting displayed yet another aspect of his creative energy, showing abstract patterns and bright colours. Tagore's artistic flexibility solidifies his standing as a multidimensional genius.

Tragedy and Philosophical Evolution in Tagore's Personal Odyssey

The tragedies of Rabindranath Tagore's personal life profoundly influenced his philosophical worldview. The unexpected deaths of his wife, children, and other close family members lace his writings with a deep feeling of empathy and contemplation. These events influenced his perspective, prompting him to delve further into the mysteries of life, death, the human condition. Tagore's philosophical journey, reflected in his wide body of work, depicts a soul dealing with the fundamental problems of existence, eventually finding consolation and understanding in the interconnectedness of all

beings. Tagore had a vibrant personal life in addition to his literary successes. In 1883, he married Mrinalini Devi and had five children. Unfortunately, his wife died in 1902, and he never remarried. Even during his marriage, people say he longed for personal company. "If you and I could be comrades in all our work and all our thoughts, it splendid," would be he reportedly wrote to his wife in a letter, "but we cannot attain all that we desire.'

Gurudev, on the other hand, had a special rapport with his elder brother Jyotirindranath's wife, Kadambari, who shared his love of reading. His sister-in-law tragically committed suicide at the age of 25 for unclear reasons, exactly four months after Tagore's wedding. Both before and after her death, he devoted poetry and books to her.

During his vacation to Argentina in 1924–1925, he also had an intellectual contact with Victoria Ocampo, who was the publisher of the literary magazine 'Sur'. Tagore died on August 7, 1941, at the age of eighty-one.

Tagore's Legacy on the International Stage


Rabindranath Tagore's global influence is unsurpassed, demonstrating his international appeal. Tagore, who received the Nobel Prize in Literature in 1913 for his work "Gitanjali," became the voice of India's spiritual history, transcending cultural and national barriers. His poetry and philosophical works struck a global chord, establishing him as India's literary and cultural global ambassador. This recognition emphasised universality of his ideas, firmly establishing him as a figure of enormous impact international literature and philosophy. Although he penned his poems in Bengali at first, English translations several of his works were highly popular in the West, promoting the message of spiritual peace and harmony. His celebrity status led to invitations to give lectures and embark on

continent-spanning friendship tours. In 1915, the British government knighted Tagore, but he resigned within a few years to protest their policy in India.

Only a few people realise that Sri Lanka's national anthem is based on a Bengali song penned by Tagore in 1938. The Sinhalese translation of the song became their national anthem in 1951.

Ananda Samarakoon, a Tagore student at Visva-Bharati University, translated the lyrics of Nama Nama Sri Lanka Mata from Bengali to Sinhalese, making Tagore the only person to have written the national anthems of three countries.

Einstein's and Tagore's friendship



Albert Einstein and Tagore both loved music. Tagore and Albert Einstein met four times between 1930 and 1931, and they marked their conversations with curiosity about each other's contributions, pursuit of truth, and love of music

According to the New York Times, Tagore wrote of Einstein after their first meeting: "There was nothing stiff about him—there was no cerebral aloofness. He appeared to be a man who appreciated human relationships, and he showed genuine concern and empathy towards me."

Tagore displayed an unshakable commitment to his artistic endeavours, personal growth, and the pursuit of India's liberation throughout his life, and his contributions have left an everlasting effect on Indian literature, music, and cultural legacy.

Tagore's Importance in the Modern World

in humanism and a profound understanding of the interconnectedness of all life, offers insightful perspectives on addressing contemporary global issues.





For a large number of Indian citizens working abroad, the the Citizenship Act, where certain categories of such persons initial teething troubles of settling down in a new country, quite distinct from one's own, are only among the first of the myriad challenges that he or she has to put up with. Culture, weather, food habits, social and societal interminglings, language, customs, traditions, practices, etc. are some of the myriad challenges that a desi finds himself caught up in, leading to a situation where he or she is even constrained to question his or her wisdom in having moved out of his or her country in the first place.

However, ploughing through the aforementioned challenges with his or her steely resolve, he or she ultimately manages to blend into the societal framework, and in a matter of some time stretching to approximately over 5 (five) years, while being comfortably ensconced in their own cocoon, they are faced with the next big question as to whether they should accept the citizenship of the country they are now part of (excluding, of course, the Gulf regions).

The answer to this query requires a lot of introspection. For some, accepting citizenship of their country of employment and residence is quite painstaking, as they know that accepting citizenship of another country and, consequently, losing out on Indian citizenship is not all that easy to come

For starters, unknown and unintended to most is the fact that upon voluntary acceptance of a citizenship of another country, their citizenship of India ceases automatically under Section 9 of the Citizenship Act, as there is, till date, no provision of a dual citizenship for an Indian, meaning he/she cannot be an Indian citizen along with being the citizen of another country. To make matters worse, immediately thereupon, a host of challenges spring up along with this automatic cessation of his or her Indian citizenship, like seeking a visa to visit his or her own country and dealing with immoveable properties involved in agricultural and plantation activities.

Fortunately, some of these problems faced by our former Indian citizens with respect to visas for travel in and out of India have been resolved through the introduction of the concept of the Overseas Citizen of India under Section 7A of

of Indian ethnicity are allowed to register with the Central Government in India so as to obtain an OCI card. The said card helps such people with, inter alia, multiple entry visas into and out of India and non-reporting to the office of the FRRO (Foreigners Regional Registration Office). However, Section 7B of the Citizenship Act lists out all the said activities that such persons holding an OCI card cannot do and are proscribed from, which proscription includes being deprived of the right to vote and the right to deal in immoveable properties in India, related to agriculture and plantations, apart from being barred from holding a public plantations, apart from being barred from holding a public office in India.


While the bar on such persons from holding public office in India is understandable and is also in sync with requirements in other developed Western economies too, what is beyond one's comprehension is such former citizens being deprived of the continuance of their Indian citizenship, including the right to vote, which is a very basic rights, considering that by accepting citizenship of a foreign county, the said person does not cut himself away from India and to mistakenly assume that he/she does so, would only be unnatural, considering that such persons have families and properties here in India, apart from being a large part of the Indian diaspora who travel to India and remit moneys to India on a regular basis and these two acts should by itself, be a cause célèbre for just by these very actions of theirs, they contribute to, inter alia, invaluably enriching the Indian economy, adding the much needed push to help grow the Indian GDP and being responsible for making India to be the largest growing economy in the world.

It is in keeping with the said spirit, WFY has, while interacting with the lawmakers in India, organized a conclave on the said subject, on the afternoon of the 16th of January at the Constitution Club at New Delhi, India, under the topic "KEEP THE DOOR OPEN" campaign, to impress upon the Indian law makers, at the Centre, to discuss, in Parliament, so as to make an appropriate provision in the law, where the equally invaluable contribution of such global Indian's and their meteoric roles in

galvanizing world trade and economies is not sacrificed at the altar of a foreign citizenship, nor the intended benefits accruing upon conferment of their continued citizenship of India, not lost out on skewered and myopic thinking of erstwhile law makers who were never faced with such a crying and dire situation of ever so willing Indians and a unwilling Government seemingly to accommodate them into the folds of mother India.

People will increasingly celebrate unprocessed food.

My bet is that "ultra-processed" will be the food phrase of the year as everyone who cares about what they eat realises that they need to reduce their use of foods that are industrially produced, employ industrially extracted components, and are designed to replace real foods while also being "addictive." Many studies have linked these foods to obesity-related chronic disorders (heart disease, type 2 diabetes, etc.) and overall mortality. One research trial backs up the addiction concept by showing that those who eat ultra-processed diets consume many more calories than those who eat moderately processed diets. It would not surprise me if non-ultra-processed products were potentially marketed as such.

Rodents Will Inspire the Next Bro-Science Fad

A space for adults to participate in rather unconstrained play, on the other hand? We require it today more than ever. I see you shaking your head, but it just goes to show how desperately you need to interact with your fellow humans in a PvP zone. You might think I'm joking, but I'm dead serious.

The most important characteristic of the PvP zone is that it is unstructured, a place where no one loses and talent is irrelevant. Nobody would deny that many of us think far too much these days. Perhaps the solution to all of our woes is to just designate a section of our parks where it is acceptable to approach someone you don't know and yell "Tag, you are it" before running away. Zones for PvP. It could, should, and, in my opinion, will happen.

Badminton is emerging.

When it comes to racquet sports, an old face is making a comeback on the main court. Badminton, which originated in China over 2,000 years ago, is the sport in which you hit a shuttlecock rather than a ball (if you're unfamiliar with the sport). It peaked in popularity in the West a century ago, and while it has been in the Olympics for a long time, it appears to be making a comeback now that we're back in the 20s.

The popularity of badminton stems from its simple regulations and faster, more physically demanding pace than tennis. It also happens to be the first alphabetical option on your Polar Sports profiles. According to Pinterest, badminton will be a new fitness fad in 2024, with an 80% increase in searches for badminton rackets and outfits in the last year.

A greater emphasis on preventive solutions will allow us to spend less money on healthcare.

Sick care will be reimagined through a combination of sustainable lifestyle adjustments and personalised solutions. In the future decades, I believe that health-care spending will change from reactive to proactive. More exercise and nutritious eating should be the first line of defence. Building on that foundation, health monitors, preventative diagnostics, and coaching and care platforms can ultimately save the US healthcare system trillions of dollars.

On the other hand, the potential of medical breakthroughs such as GLP-1 medicines opens up much-needed opportunities for genuine change. The first true medicine for obesity will require us to reconsider how we see health, both personally and medically. My goal is that we will find ourselves grappling with the nuance in the centre, figuring out how to use

medical discoveries while also paving the way for long-term sustainability by making our environment more inviting to healthier behaviours.

Research on strategies to expedite recovery.

Many healing treatments have gained popularity in recent years. It's become a crucial element of the training process for athletes of all levels, from foam rolling to massage guns. Cold water exposure, particularly through ice baths or similar sorts of chilly immersion after training, has gained significantly in popularity.

In 2024, we expect to gain a better understanding of cold water immersion, including its benefits such as relieving muscle soreness. For example, building on their pilot study from 2022, researchers in the United Kingdom will perform the largest, randomised, controlled experiment on the subject to examine if cold water exposure helps treat anxiety disorders and depression.

Experiencing international flavours.

I hope that the desire for home cooks to experiment with more global flavours and ingredients from many international cuisines continues. According to my social media feeds, 2023 was the year of the chilli crisp.

Mushrooms that have medicinal properties

This is a current trend that I believe will gain mainstream attention in 2024. It appears like mushroom coffee is here to stay, which is a great way to get your fungus dose, but I also hope that the hoopla pushes people to cook with more various species of mushrooms.

Aside from the standard buttons and bellas, variations like chanterelle, shiitake, and enoki are very common in most large grocery stores these days. Most medicinal mushrooms are adaptogenic, which means they help the body cope with stress, something I believe many of us might benefit from.

The "Not Too Sweet" era will continue to gain traction.

Growing up in an Asian-American home, the best compliment someone could pay for a dessert was "it's not too sweet." This intolerance to cloying sweetness, which I developed at a young age, has caught on with the general public. From the long-overdue realignment of the soda industry towards sparkling water as the hero, to the continued rise in popularity of Asian food with its greater emphasis on savoury over sweet, to the all-too-common experience of asking your server for a wine recommendation that's "on the drier side," sweetness is marginalised. However, while sugar has been demonised for decades for its nutritional value, consumers are now limiting their sugar intake for reasons other than health. Even those who aren't adamant about avoiding sugar are cutting back because they want to be able to taste their food rather than having their taste buds swamped in a flood of sweetness.

With rising scepticism about the healthfulness of artificial sweeteners and a general preference for more natural foods, diets in 2024 and beyond may not only continue to reduce sugar levels, but whatever small amounts of sugar they do consume will come from natural sources rather than synthetic ones.

We'll stop complicating the concept of living well.

People will want stability and simplicity in their health and exercise routines as their lives become more chaotic and tumultuous. 

Sandesh

During ancient times, the Indian subcontinent popularized milk-based sweets, and Sandesh's origins can be traced back to this period. However, it wasn't until the 16th century, during the time of the Bengal Sultanate, that Sandesh rose to prominence as one of Bengal's most popular sweets. It gradually became a necessary sweet offering at festivals, festivities, and religious rites, as well as an integral aspect of Bengali cuisine.

Sandesh was traditionally made with only chhana and sugar, but over time, various flavours and ingredients were added, broadening its range and appeal. There are several different types of Sandesh available nowadays, including Nolen Gur Sandesh (made with date palm jaggery), Pista Sandesh (with pistachios), Kesar Sandesh (saffron-flavoured), and many more.

Cultural Importance: Sandesh has enormous cultural importance among Bengalis. It is a symbol of love, affection, and sharing one's delight with others. In Bengali literature, poetry, and songs, Bengalis frequently mention Sandesh as a metaphor for sweetness, gentleness, and the essence of Bengali hospitality.

- 2. Sandesh is extremely adaptable and can be fashioned into a variety of shapes, ranging from basic round balls to elaborate designs created with moulds. Sandesh's shape is termed "moulding."
- 3. Kolkata (previously Calcutta) is famous for its delectable Sandesh. Sweet shops in Kolkata, such as K.C. Das, Bhim Nag, and Ganguram, have become famous for their ability to create delectable Sandesh.
- 4. Sandesh is not just popular in Bengal but also throughout India, particularly in areas with a large Bengali population.
- 5. Sandesh has evolved to suit the modern palate as the times have changed. Chocolate sandesh, mango sandesh, and even fusion combinations like paan (betel leaf) sandesh have become popular.

Sandesh is still revered by Bengalis as a symbol of their rich culinary heritage, and it has a global following for its delicate texture, exquisite flavours, and perfect balance of sweetness.

Here's how to prepare Sandesh, a popular Bengali dessert, the traditional way:

Ingredients:

- 2 litres of full-fat milk
- 1 lemon
- 1 cup powdered sugar; a few saffron strands (optional)
- 1 tablespoon pistachios, chopped (for garnish)
- 1 tablespoon chopped almonds (optional)





Step-by-step instructions:

- 1. Begin by making the chhana (curdled milk). Pour the milk into a big pot and bring to a boil over medium heat. To keep the milk from sticking to the bottom of the pan, stir it occasionally.
- 2. While heating the milk, squeeze and filter the lemon. Set aside the lemon juice.
- 3. When the milk reaches a boil, remove it from the heat and set it aside for a minute. Then, while constantly whisking the milk, gradually add the lemon juice, a little at a time. The lemon juice's acidity will curdle the milk and separate the whey.
- 4.Once the milk has completely curdled and the whey has separated, strain the mixture through a fine sieve or muslin cloth. Set aside the whey to be used in other dishes, such as making dough.
- 5. Rinse the chhana under cold running water to remove any lemon juice sourness. Gather the cloth's corners and squeeze lightly to eliminate extra water.
- 6. Hang the chhana bundle for 30 minutes to absorb any remaining moisture. This produces a soft, crumbly chhana.
- 7. After 30 minutes, transfer the chhana to a clean, dry surface and knead it with your palm's heel until it is smooth, creamy, and lump-free. This stage is critical for achieving the desired texture for Sandesh.
- 8. Transfer the kneaded chhana to a heavy-bottomed pan. Cook for about 5 minutes on low heat, stirring often.
- 9. Mix the powdered sugar until it is completely incorporated. Cook and stir for another 10–15 minutes, or until the mixture begins to leave the sides of the pan and forms a hard mass.
- 10. At this point, add a few strands of saffron soaked in a tablespoon of heated milk to improve the flavour and give the Sandesh a beautiful yellow colour. Combine this with the chhana mixture.
- 11. Remove from the fire and set aside for a few minutes to cool until the mixture is cold enough to touch.
- 12. Grease your palms with ghee or butter and scoop out a tiny amount of the hot Sandesh mixture. Make little, spherical Sandesh balls by rolling them between your palms. Moulds can also be used to form the Sandesh into various designs.
- 13. Decorate the Sandesh balls with chopped pistachios and almonds, carefully pressing them on top.
- 14. Refrigerate the Sandesh for about 1-2 hours to set and harden up.

The Sandesh is ready to serve once it has cooled and set. Enjoy this scrumptious Bengali sweet as a pleasant treat or on special occasions with friends and family!



People use the above filters according to their experiences, upbringing, etc. That is the reason we say that each person's truth is different than what the truth actually is.

A retrospective of the Corona Times and the fear of a new wave

"Soon after her return from a business trip to Hong Kong, Beth Emhoff dies from the flu or some other type of infection. Her young son died later the same day. Her husband, Mitch, however, seems immune. Thus begins the spread of a deadly infection. For doctors and administrators at the U.S. Centres for Disease Control, several days pass before anyone realises the extent or gravity of this new infection. They must first identify the type of virus in question and then find a means of combating it, a process that will likely take several months. As the contagion spreads to millions of people worldwide, societal order begins to break down as people panic."

If the excerpt above sounds familiar, it isn't because it is the story of the COVID-19 nightmare that we have all been living for the past two and a half years. It is a summary of the plot of a 2011 Steven Soderbergh movie, Contagion, starring Matt Damon, Marion Cotillard, Kate Winselt, Gwyneth Paltrow, Lawrence Fishburne, and Jude Law. The similarities, however, are startling. "In a flashback to the spillover event, a bulldozer from Emhoff's company clears a rainforest in China, disturbing bats. A bat seeks shelter on a pig farm and infects a pig by dropping a contaminated piece of banana. The pig is then slaughtered and prepared by a chef in a Macau casino, who, without washing his hands, transmits the virus to Beth via a handshake."

To say that the world as we knew it has literally turned on its head since November 2019 wouldn't be too much of an exaggeration, especially if you were to transport yourself into the future and look back at the years' that we have all been living through recently. The rapid spread of an invisible foe has left a trail of death and destruction in its wake. Global, regional, and domestic trade and commerce were slowing down to a glacial pace as country after country chose to hunker down, close their borders, and restrict the movement of their own people in the hope of reducing transmissions. The immense pressure on establishment structures to cope with growing food, energy, and supply chain shortages and national healthcare systems being overwhelmed as countries tried, and in most cases failed, to keep up with unimaginable patient volumes. Chaos has reigned supreme. And, through this period, first imperceptibly and then, almost intentionally, the world order has changed as countries and regions have chosen to look inward and prioritise the needs of their own people over others, re-shore and nearshore critical global supply chains, and stand up and count those that have stood beside them in their deepest times of distress.

So, what has been the role of communications through all this, and what does it mean for the industry as a whole going forward? Well, here are a couple of thoughts for you to consider:

- Communications have been central to managing almost all aspects of this pandemic. From the burdensome task of the WHO, CDC and country leaders having to tell people that the virus was upon us and that it was prudent to hunker down in the face of the period of upcoming uncertainty; to people turning to instant messaging platforms and other forms of social media to search for and notify others of the need for blood, oxygen, medicines and hospital beds; to governments creating and rolling out apps that would allow us to register for critical vaccines, and also allowed them to 'track and trace' people who were possibly spreaders themselves or had recently attended allegedly super-spreader events; and, some of the world's leading healthcare institutions and leading global academic medical colleges creating and socializing content via the internet on global protocols and best practices in combating this disease and treating patients at home. Governments will continue to rely on communications to calibrate the dropping of our national and individual safeguards and then, perhaps, remind us every year that there is an inoculation that needs to be taken as the pandemic hopefully recedes and gives way to a series of regional, country, and later community-specific hotspots.
- Communications have been the lifeblood that has kept us afloat. If asked to name three industries that have proven their credentials and value to society beyond doubt over the past two and a half years, there are many who will no doubt say, 'e-commerce, electronic communications platforms (Zoom, MS Teams, Webex, Blueleans), and OTT'. While I admit that the leading e-commerce platforms and their global supply chains have allowed people to continue to have food on their tables, toiletries in their bathrooms, and the luxuries that they choose to enjoy in their homes, I believe that e-commerce, seen in isolation, would need to yield its pride of place to the increasingly omnipotent power of digital commerce, which is increasingly central to multiple facets of our daily lives. Equally, there is no denying the significant contribution of online communication platforms like Zoom, MS Teams, Webex, Blueleans, and Moodle and the role that they have played in allowing us to continue to carry on with our professional and personal lives at work or at school without having to ever travel to meet with our colleagues, peers, clients, teachers, or would-be customers. And yes, OTT and other Internet-based entertainment and communications platforms have kept us abreast of the latest developments across matters of global and national interest, the lives of our favourite actors, and the evolution of countless stories across soap operas, movies, and quiz shows. I, for one, do not see all of these developments or the benefits they have provided melting away as soon as we all start to look at the pandemic in our rearview mirrors.
- Communications have collapsed in time and distance. If the pandemic has been devastating on co-located communities, it has also been heart-wrenchingly cruel for those of us, like me, who, on account of their personal or professional choices, have found themselves living overseas, more often than not, far away from their families. WhatsApp, Messenger, and other internet-based communications platforms have been invaluable and hugely empowering for people who have desperately tried to stay abreast of the wellbeing of their loved ones living in another country during these times. Gone are the days when you needed to stand in long lines to make an international call or wait till a particular hour when the call rates were lower. Today, you can call as often as you like, whenever you like, on video or audio, and even go so far as to order food online for your children in Paris while you are in the United States, and even track the progress of the deliveryman dropping off the parcel of food in real-time at no extra cost. We cannot overstate the power and liberation we feel when we can do something so fundamental to our lives with just a few clicks on our phones. Equally, countless experiences such as these have removed all doubt around the power and omniscience of digital platforms and media, and more and more governments, companies, news organisations, and nonprofit foundations will embrace the concept of data being the new oil. Shouldn't you?
- From the point of view of a lifelong student of communications, the intervening period between November 2019 and March 2022 has taught us many life lessons. Primary among these is the fact that life—and communications—don't stop in the face of economic crises, wars, or a global pandemic. If anything, they intensify. You need to find ways to drink from the firehose, adapt your perspectives, adopt new habits and a plethora of tools, and continue doing what you do best. And, while communications is in many ways the lifeblood that keeps things moving, a lot of benefits that have accrued from effective communications to the global economy and people at large haven't been the work-product of a body of outstanding communications professionals with job titles that clearly identify them as communications, crisis, or PR managers sitting in a corner office. In many cases, the solutions have emerged organically out of good old common sense, subject matter expertise, the lack of any other option, or a combination of all of these, and someone who had the vision and foresight to piece this all together. Therefore, it is critical today, perhaps more than ever before, to approach the discipline of communications with open eyes and a broad appreciation of the various factors at work. And to understand and appreciate that our role as professionals is often closer to that of effective 'play makers' than players ourselves. Others can appropriate our skills in our profession. We are in a profession where we need to harness the wealth of knowledge and resources we see around us and use them to advance our goals or the goals of our clients.
- From a global practitioner's point of view, there are few things that create greater opportunities for consulting firms than fear and doubt. The fact that governments around the world have created a series of new tariff and non-tariff barriers to protect their economies and their people from the vagaries of the external world, are urging corporations to re-shore or near-shore their operations to mitigate supply chain risk and create new jobs, and are willing to enter into a flurry of bilateral agreements or initiate significant policy changes to cement new relationships or jumpstart domestic economic growth can only augur well for the global communications and public affairs industry. The coming decade will also see significant investments going into areas like healthcare, insurance, education, infrastructure, manufacturing, supply chain strengthening, and digital commerce as the global economy tries to learn from its mistakes and be better prepared for the eventuality of the world facing another horror like COVID-19.

As global communications professionals, we can choose to look upon the experiences of the COVID-19 pandemic in two ways: feeling sorry for ourselves and bemoaning the loss of several productive years of our lives in the short term, or learning from our experiences and finding niches where it makes sense to play the long game and sufficiently differentiate ourselves from others. I choose to do the latter.



India's economic trajectory through 2024 tells a fascinating story, establishing the country as the fastest-growing G20 economy. India has now reached the S-curve's key phase, which is marked by a dramatic increase in urbanisation, industrialization, household income, and energy consumption. This period often lasts several decades and is characterised by tremendous expansion in these areas.

Factors influencing India's positive economic forecast for 2024

- Stable economic fundamentals: India's GDP of US\$3.75 trillion places it as the world's fifth-largest economy. The Reserve Bank of India's forecast of reaching \$5 trillion by 2027 reflects a continuing, increasing trend. According to S&P Global Ratings, India's economic development prospects would remain strong in the medium term, with GDP predicted to expand by 6 to 7.1 percent over the fiscal years 2024–2026
- A thriving industrial manufacturing industry: The industrial manufacturing sector has grown significantly, drawing major global manufacturing and technological titans. Manufacturing has been revitalised by state industrial policies and incentives, along with successful production-linked incentive (PLI) systems, with noteworthy success stories like Apple and Foxconn.

Strategic attempts to cut logistical costs and focus on regional connectivity help to ensure long-term economic prosperity.

Leading international corporations have established local subsidiaries and contracted electronics manufacturing services to Indian enterprises.
- Ease of doing business: Reforms to the bureaucracy, such as digitising regulatory processes, contribute to a business-friendly climate.
- Resilient trade and services export industries: Despite difficulties attracting foreign direct investment in the face of global uncertainty, India's commerce and services export sectors remain solid. By the end of 2023–24, it is predicted that service exports will surpass \$400 billion, showcasing the country's resilience in the face of geopolitical shocks. India is also pursuing full free trade agreements with key markets such as the United Kingdom, Australia, the Gulf Cooperation Council, and the European Union.
- Positive growth sectors: digitalization, sustainable production and infrastructure, trade facilitation, expanding manufacturing capacity, semiconductors and technology R&D, and financial sector growth are key growth areas for India in 2024.
- Young demographic advantage: India's position as the world's most populated country, with a median age of 28.2 years, contributes to the country's economic vigour. Domestic demand recovery, particularly in private consumption and household expenditure, supports corporate development ambitions.
- Rise of non-metropolitan hubs: The availability of talent and connectivity to metropolitan majors has resulted in the rise of Tier-2 and Tier-3 cities in India (as defined by population parameters), allowing service

- and manufacturing multinational corporations to establish themselves in more cost-effective locations. This has had a good impact on the regional economy.
- India ranks 16th on the FDI Confidence Index for 2023 and is the world's fourth-largest retail market. Discretionary spending power is increasing, with India's average per capita income above US\$2000 and expected to hit US\$12,000 by 2047. The large middle-class and underserved consumer base in nonmetropolitan cities piques the interest of several international retail conglomerates looking to expand into new markets. Branded products, such as fashion, cosmetics, jewellery, footwear, timepieces, food and beverage (F&B), and furniture, are growing in popularity and becoming necessary lifestyle items for both business and pleasure.

 Emerging sectors and dedication to sustainability: India's emphasis on emerging industries such as healthcare, fintech, renewable energy, electric vehicles, information technology, and semiconductor manufacturing is in line with global trends. A commitment to decarbonisation and attaining 500 GW of renewable capacity by 2030 demonstrates a

forward-thinking strategy.

sustainability Corporate and Sustainability and environmental, social, and governance (ESG) factors are gaining traction in the corporate sector, and they help to promote responsible and ethical business practices. Green technology skills are becoming increasingly important, producing jobs and promoting growth in green Currently, business. 'Business Responsibility and Sustainability Reporting by Listed Businesses' (BRSR) applies to India's top 1000 listed businesses (by market value). Also, the BRSR Core requires the top 150 listed companies in India to provide assurances on 49 core indicators that are important to the business. This applies to the fiscal years 2023–24 and 2024–25.

 Policy emphasis on education reforms and skilling efforts tackles the changing nature of occupations, preparing the huge youthful demographic cohort for

future problems.

 State stability and investment opportunities: While the 2024 federal elections introduce uncertainty, states with non-renewable local governments, such as Karnataka, Tamil Nadu, Telangana, Uttar Pradesh, Gujarat, and Maharashtra, present appealing investment opportunities. Hot sectors for India in 2024: Emerging industries such as battery energy storage, green hydrogen, biotechnology, clean mobility, food processing, AVGC (animation, visual effects, gaming, comics), and semiconductor chip manufacturing are encouraging foreign companies to consult local experts to assess whether their business lines align with promoted economic activity in state industrial policies and thus tap key fiscal incentives. Given India's aim to decarbonise and reach 500 GW of renewable energy capacity by 2030, associated sectors would seek foreign investments and expertise. Healthcare and insurance, fintech, renewable energy and climate tech, electric vehicles and automobiles, IT and services, real estate and infrastructure, fast-moving consumer goods (FMCG), logistics, R&D, global capability centres, and artificial intelligence (AI) are among the key industries enticing foreign investors in India in 2024.

The legal industry is changing at a dizzying rate. This fiercely competitive and intricate industry faces a plethora of obstacles, including the rising cost of living, the growing need for specialised knowledge, the growth and disruption of alternative legal service providers (ALSPs), changing client expectations, the expansion and contraction of practice areas, and a host of other issues. However, the industry will change, grow, and eventually overcome those obstacles. Over the past few years, legal companies and attorneys have demonstrated an unexpected degree of adaptability, sincere resilience, and a general willingness to change. Legal companies and attorneys are expected to advance even further in 2024 by embracing cutting-edge technology, adopting creative payment methods, breaking into new markets, and more.

Key legal developments to look forward to in 2024:

Acceptance of substitute legal expenses: Although the billable hour has long been the standard billing technique, clients are raising concerns about the model, claiming it generates perverse incentives, leads to duplicate billing, fosters inefficiencies, and offers a poor return on investment. However, 2023 saw 6% growth, indicating a sharp slowdown in the sector's growth. Experts widely recognise the causes of decreased growth. Geopolitical unrest, the macroeconomic climate, the pandemic aftermath, and increased regulatory complexity have caused the professional services sector to suffer.

Smaller legal companies seek more organic growth: It's difficult to expand a legal practice. But expansion will be extremely challenging in an uncertain economic climate, when new competitors could disrupt the legal market and income could decline. Still, legal companies have high growth aspirations, as evidenced by the most recent Lexis Nexis study. Moreover, the emphasis is on the organic, as opposed to past years. The report demonstrated that small businesses prefer to grow organically—that is, by expanding their marketing and business development departments—as opposed to using more conventional strategies. Survey participants observed that comprehensive approaches to advertising tactics have proven to be effective, with social media, public relations, and the internet all focused on offering education.

The Ascension of Generative Artificial Intelligence: ChatGPT, DALL•E, Jasper, Soundraw, and other generative artificial intelligence (AI) systems were the topic of 2023. Not just in the legal area, but throughout the economy and around the world. A recent LexisNexis report, Generative AI and the Future of the Legal Profession, sought to better comprehend the sector's existing awareness and deployment of AI. And, while current use appeared to be low, with just over a third (36%) of respondents indicating that they use the technology, anticipated use appeared to be massive. To find solutions, lawyers are increasingly turning to generative AI. They are utilising technology to create briefs, documents, and content. They are using AI to generate ideas, improve processes, and streamline operations. They draft, negotiate, and analyse contracts. Lawyers are employing reliable legal AI systems to significantly accelerate and improve their legal research. They are also employing AI in everyday jobs, such as the most fundamental types of communication. In short, AI will begin to transform the legal profession in 2023 and will become even more prevalent in 2024. The technology has an air of inevitability about it, and lawyers who do not use it or who do not embrace the benefits it provides will eventually fall behind.

Customer service may not be as important to retention as solutions are. More than ever, clients are expecting faster turnaround times, innovative billing models, improved communication channels, and much more. The firm acquires clients, but smaller businesses can only expand by exceeding their expectations.

Therefore, in 2024, discovering organic approaches to draw in and keep customers will probably be very popular.

The 24-year-old Kiwi batsman of Indian origin showcased his talent in the ICC World Cup in India (in November) when he slammed three centuries and, more importantly, ensured New Zealand entered the semi-finals of the World Cup.

For someone who had made it to the New Zealand side following the injuries to Kane Williamson, Rachin was super quick to prove his credentials. He did the 'unthinkable' when he scored a century against defending champion England in his opening match of the tournament. Not only that, he emerged as the highest scorer as a debutant when he scored 575 runs, which is a record.

Rachin's Indian roots become very obvious when he speaks. Though there is a tinge of the Kiwi accent, there is a strong Indian accent, which clearly shows his South Indian roots.

Rachin's father, Ravi Krishnamurthy, was born in Bengaluru. A software engineer, he was also a very avid cricket fan who closely followed the exploits of Sachin Tendulkar and Rahul Dravid

"It was my father who initiated and developed my love for cricket and cricketers. He was following the fortunes of the Indian team wherever they went, and soon his love for the game transcended over to me," said Rachin.

In fact, Ravi, who shifted to New Zealand in 1997, was very particular about the idea that his son Rachin should become a cricket player. "At home, our discussion would invariably be about whom and when India would play next. And then the conversation would veer towards how nice it would have been had I or my father been playing for India, "Ravin said.

Once Rachin was born in Wellington, his father, Ravi, wanted him to be a cricketer who would don the Kiwi All Blacks. Such was his mission and passion that he would end up driving a nine-year-old Rachin more than 70 to 100km per day in order to attend cricket coaching.

"Those early days were quite tough. Initially, I was reluctant to go to such lengths—leave home early for school, then return and leave for cricket practice. This involved a lot of

travel and, needless to say, took a hell lot out of me," said Rachin.



If Rachin had doubts, Father Ravi was quite clear about his son's future. He kept prodding and pushing Rachin further and further in order to pursue his dreams.

Slowly but surely, Rachin increased his pace and made his presence felt in the Kiwi junior squad with a string of good performances. His batting prowess soon made him famous, as he was one of the most prolific scorers in the Plunkett Shield, the domestic circuit of New Zealand cricket. Apart from that, Rachin used to travel every year to Bangalore to play club cricket. "That was an experience I would eagerly await. My parents hail from this city, and I am very comfortable with the people and cuisine," he said.



From a very young age, Rachin admired Sachin Tendulkar. "I used to adore him—for just about everything. The way he batted and the way he conducted himself on and off the field. He was the epitome of what a cricketer should be. I wanted to be like him in terms of a batsman," revealed Rachin.

Rachin made his debut for New Zealand A against Pakistan A in October 2018. "That was a landmark in my career. I could feel the pressure and was not able to give my best in that match," said Rachin.

Soon, the International Cricket Council (ICC) acknowledged him as one of the finest young talents.



Rachin's big moment came when he was chosen to play for New Zealand in their away series against India in 2021. Although he did not score any tall runs or play any spectacular innings, he will be best remembered for his 91-ball knock of 18 runs, which helped the Kiwis avoid a defeat in the Kanpur Test match. "I had dreamt of scoring big in the series against India, but the best that I came up with was a 91-ball 18 runs. I was batting at No. 8, and India was poised to post a win. I batted with a lot of grit, which enabled my team to latch on to a draw. I will not forget that innings for the rest of my life," he said.

Thereafter, he played a couple of series for New Zealand but came on his own in the one-dayers with his big hitting and attacking style of batting. "I think I don't have the patience for tests, as I am an attacking batsman. ODI's is tailor-made for my style of batting, and I knew I would be a success in the white ball format," he added.

Rachin experienced his moment of glory at the ICC World Cup, held in India earlier this year. Rachin was included in the First 15 and was not supposed to play an active role in New Zealand's campaign.

But Lady Luck shined on him when former captain Kane Williamson was injured for New Zealand's initial five games, giving him a chance to prove himself.

He did just that in his debut ODI World Cup match against England. This match was played at the Narendra Modi Stadium, the world's largest cricket stadium. Batting at No. 4, he had a dream debut when he scored a strokeful 123 runs. In the process, he became one of the 15 players in the world to score a century on his World Cup debut. Then, he scored a couple of centuries more to cement himself as New Zealand's Mr. Dependable.

Rachin, whose parents came to India during the World Cup, feels he has a lot more to offer. "I feel that I can be among the best batters in the world in the coming years. I just have to keep my focus going."

The debate around nepotism gained widespread attention in 2017 following the passing of actor Sushant Singh Rajput. His death led to discussions about mental health in the industry and fueled conversations about the challenges faced by outsiders



trying to make their mark in Bollywood.

Responding to the criticism, some industry insiders have called for a more inclusive and merit-based approach to casting and filmmaking. The rise of independent cinema and the success of actors and filmmakers without established Bollywood connections also highlight a shifting landscape within the industry.

This controversy led to a wider conversation about power dynamics, privilege, and the need for a level playing field within the film industry. It prompted other actors and filmmakers share their perspectives on nepotism and the struggles faced by outsiders. The incident also sparked discussions about the impact of favoritism on mental health and the overall well-being of individuals trying to establish themselves in the industry. While the Kangana Ranaut and Karan Johar controversy brought attention to the issue, it did not mark the end of discussions around nepotism in Bollywood. The industry has since witnessed a continued dialogue on the inclusivity, for opportunities, and the recognition of talent over lineage. This controversy remains significant in the ongoing narrative about nepotism and its implications for the Indian film industry.

Overall, nepotism in Bollywood remains a complex and contentious issue, reflecting broader concerns about representation, inclusivity, and the balance between lineage and talent in the entertainment business. The ongoing dialogue surrounding nepotism indicates a growing awareness of the need for change and a more diverse and equitable film industry.


